
Performance Curves







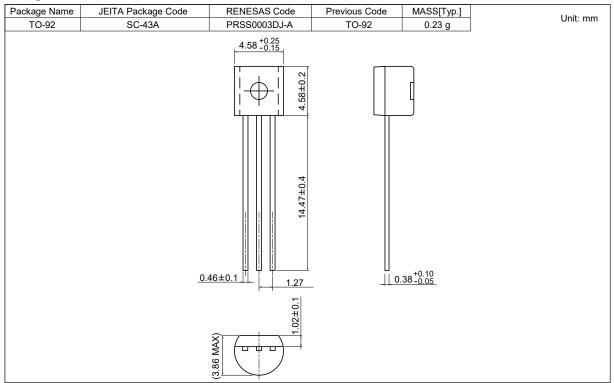
